- B). I have never been convicted of a "crime of moral turpitude" or "crime of violence";
- C). I shall conduct myself at all times with the ethics, integrity and professionalism expected of an instructor representing the NRA and certified by it's Law Enforcement Division;
- D). I shall never do anything that unduly damages the credibility of, brings disgrace to, or otherwise conveys negative attention upon the NRA, any of it's programs, or upon the NRA's Law Enforcement Division;
- E). I shall, as a certified "Law Enforcement Firearm Instructor" of the NRA's Law Enforcement Division, at all times conduct myself in strict accordance of all firearm safety rules; and,
- F). I fully understand and acknowledge that certification as an NRA "Law Enforcement Firearm Instructor" is a privilege, not a right, that said certification can be revoked at the NRA's sole discretion, and any monies having been paid for membership, certification or training forfeited.
